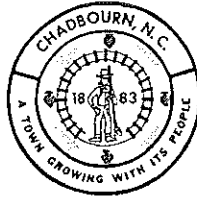


# CHADBOURN TOWN COUNCIL AGENDA AND *BOARD OF ADJUSTMENT*
